Re: City of Richmond Zoning Code Refresh

Dear Mr. Vonck:

As the City of Richmond moves towards finalizing revisions to its Zoning Ordinance, the Department of Historic Resources (DHR), which serves as Virginia's State Historic Preservation Office, offers the following for your consideration.

Through its many programs, DHR leverages historic preservation objectives to support goals of affordable housing, sustainability, and smart growth. The *Richmond 300 Master Plan* clearly reflects the City's understanding of the value of its historic properties in defining the character and economic potential of its neighborhoods (Goal 3). To establish a framework by which the City may realize the real economic benefit of historic preservation, the Master Plan calls for the creation of a city-wide preservation plan.

As directed by the Master Plan and with financial assistance from DHR, the City has drafted a *Cultural Heritage Stewardship Plan*, which is currently under consideration by an *ad hoc* subcommittee of the Planning Commission. Amongst its many valuable suggestions, the Stewardship Plan recommends that the City "Develop zoning districts that support, protect, and enhance neighborhood character, especially in areas that are not protected by or not interested in establishing an Old and Historic District" (Section 5.2, Objective 4), a recommendation that was identified as a priority for over 64% of respondents in your 2023 public survey.

Rezoning should respect the existing character, scale, and massing of the City's historic districts, regardless of whether they are local, state, or federally designated. As a Certified Local

We encourage the City to adopt the Stewardship Plan and seriously consider its recommendations <u>prior</u> to finalizing revisions to its Zoning Ordinance.
